### SOURCE PROTECTION COMMITTEE MEETING 23

– November 3, 2009 at the Campbellford Arena Auditorium, Campbellford

#### Welcome to the Municipality of Trent Hills

  - This is an extension of approximately seven months from the initial deadline but falls short of the requested extension by two months. MOE suggested that the consultation period may be reduced in order to meet the revised deadline.

#### MOE Q & A Session

Heather Malcolmson, MOE Source Protection Manager, will attend the next SPC meeting to answer questions that have recently been raised by the Committee (e.g. including aquacides as a local threat). As Heather manages the technical aspect of source protection planning, this provides an opportunity for the SPC to bring forward additional questions. ## **Draft Proposed Assessment Report – Report Sections & Technical Reports**

### **A. Municipal Systems: Draft Vulnerability**

- Lloyd Lemon, Jagger Hims Ltd., provided results for the 13 City of Kawartha Lakes municipal groundwater systems. He also identified the potential for cross-border concerns with adjacent Source Protection Regions for a number of systems. The work is currently being peer reviewed.
- Dirk Kassenaar, EarthFx (XCG Consultants), provided findings for the seven groundwater systems in the southern portion of the Source Protection Region. Peer review is underway.
- Janet Noyes, XCG Consultants showed results for six City of Kawartha surface water systems.

### **B. Tier 2 Water Budget – Janet Noyes, XCG Consultants**

- Preliminary modeling results for the Havelock municipal well system Tier 2 water budget were presented. The report is currently being peer reviewed.

## **Bay of Quinte Remedial Action Plan: Phosphorus Control Efforts – Jim Kelleher, SPA Liasion**

An overview of phosphorus control efforts for the Bay of Quinte was provided which has included both point source cleanup (e.g. upgrades of STPs, stormwater management) and non-point source actions (e.g. agricultural stewardship activities). A phosphorous management plan is being prepared to guide future control efforts.
